1. Payment due on or before contract start date. A 3% online early payment discount is available for full payment online at least one month prior to the contract start date (cannot be redeemed in conjunction with any other offer).
2. Annual berthing paid monthly by Direct Debit: An initial double payment is taken to cover your first and last payment for your final month in the marina – whenever that may be. Following your initial double payment 11 equal monthly payments are taken to cover your first year's annual contract. Your contract will auto-renew each year and 12 equal monthly payments will be taken. If you decide to leave, at end of your contract, your 'final' payment will be used instead of taking a payment in month 12.
3. Monthly berthing: payable in advance per month or part thereof. A month denotes a stay of 30 nights.
